The center has also successfully achieved five consecutive deficiency free surveys from the Indiana State Department of Health (ISDH) and has been awarded a number one ranking through AHCA's Top Line Report in Indiana since 2017. The Laurels of DeKalb's dedicated team is actively engaged in improving clinical outcomes for their residents and is embracing the "Laurel way" of exceeding expectations by delivering compassionate care to their guests and residents every day.

The Brownsburg Meadows Assisted Living Community's team is providing person-centered care to its residents by cultivating positive relationships and an environment of trust. The center offers Virtual Dementia Training to staff as well as to families to help them gain a better understanding of what someone living with Alzheimer's or Dementia experiences on a daily basis. Residents enjoy a maintenance-free lifestyle and participate in a variety of activities that are carefully planned to keep them engaged.
